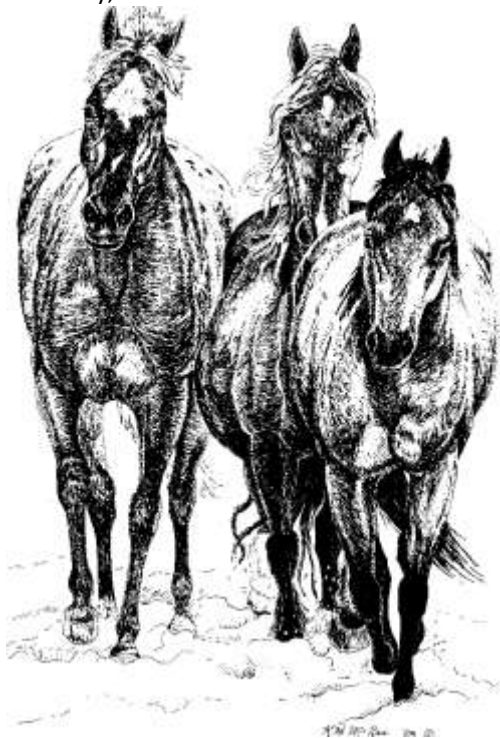

Consignors Meeting Results

Before the General Membership Meeting February 9th, there was a Consignors Meeting. At this meeting the club passed several motions in regards to the future CCQHA Horse Sales, and CCQHA Sales Futurities. The motions that were passed are paraphrased below:

- All Futurities this year will be held on Fri. September 4th, except the Yearling Futurities which will be held on Sat. September 5th. The Horse Sale will be held on Sat. September 5th also.
- Lori Vance will sell 50/50 raffle tickets on the day of the sale. The proceeds will go toward supporting the Sale Futurities in 2011.
- The Breeders 4 & 5 Year Old Futurity class will be separate from the Sale 4 & 5 Year Old Futurity class. They will each have their own entries and prize money from now on.
- Sale Futurity entry fees were raised an additional \$25 which will be used to support the Sale Futurity pay outs.
- The Sale 4 & 5 Year Old Futurity class has been split into two classes. The Sale 4 Year Old class will be a Working Cow Horse Futurity, and the Sale 5 Year Old class will be a Team Roping Futurity.
- The Sale Futurity's 5 Year Old Team Roping class will be split into a Heading class and a Heeling class. Each will have its own entry fee and pay outs.
- Consignment fees for the Horse Sale will be dropped by \$25, leaving the Weanling Consignment Fee at \$75, and Yearling and up at \$100.
- This year's Horse Sale will be limited to 40 Weanlings and a total of 70 Horses.
- From now on, new club members will not be allowed to consign weanlings their first year.
